

Coronado School of the Arts Foundation Deposit, Payment, and Refund Policy

This refund policy applies only to student fees paid for the COSA program. The policy does not apply to donations and /or contributions (i.e., the Annual Campaign) to the CoSA Foundation, or any school fees paid to CHS.

Any refund will be net of any student fees still unpaid from prior years. Payments will be made by check. Payments will generally be made within 30 days of receipt of a written request either delivered to the COSA office or mailed to the Foundation (CoSA Foundation, P.O. Box 181587, Coronado, CA 92178).

Deposit

Upon acceptance to CoSA and CHS, students must confirm their intention to attend the program in the fall by signing and returning the acceptance letter and paying a non-refundable \$300 deposit. The deposit will go toward the student fee for the coming school year.

Interdistrict transfer students will be notified by Coronado Unified School District when they have been admitted to CHS. Coronado residents are automatically admitted to CHS.

For students who are admitted on or before June 3, 2010, deposits are due by June 10, 2010. For students admitted after June 3, deposits are due within five (5) business days of the date of admission.

Returning students are required to pay a deposit to secure a place in CoSA for the coming school year no later than June 10, 2010.

For families in need of financial aid, the deposit may be waived if a completed financial aid application is returned by the applicable due date instead.

A student's space in CoSA is guaranteed once the acceptance letter and either a deposit or financial aid application are received by the CoSA office.

Payments

The \$1,500 student fee (less the \$300 deposit) may be split into eight monthly payments of \$150 via credit card or direct debit on the 25th of each month beginning August 25, 2010. A 10% discount will be applied to student fees received paid in full by August 12, 2010.

Refunds

Deposits and monthly payments are non-refundable.

If the entire \$1,500 student fee was paid in full at the beginning of the school year, refunds will be given as follows for students leaving before:

August 25, 2010: \$1,200
September 25, 2010: \$1,050
October 25, 2010: \$900
November 25, 2010: \$750
December 25, 2010: \$600
January 25, 2011: \$450
February 25, 2011: \$300
March 25, 2011: \$150
After March 25, 2011, no refunds will be issued.

If the student fee was paid by the early discount deadline in the amount of \$1,350, refunds will be given as follows for students leaving before:

August 25, 2010: \$1,050
September 25, 2010: \$900
October 25, 2010: \$750
November 25, 2010: \$600
December 25, 2010: \$450
January 25, 2011: \$300
February 25, 2011: \$150
After February 25, 2011, no refunds will be issued.

Withdrawal after the above period will result in no refund.

This policy applies to students withdrawing from CoSA for any reason, voluntary or involuntary.

Refund requests must be made in writing and either delivered to the COSA office or mailed to the Foundation (CoSA Foundation, P.O. Box 181587, Coronado, CA 92178).

This refund policy is effective for the 2010-2011 academic year.
