Participant's Agreement

I understand that:

- ◆ I must maintain a 2.0 GPA and have no failing grades to participate in school sponsored field trips and activities.
- ◆ The use or possession of alcohol, tobacco (chewing or smoking), or drugs at any event, performance, rehearsal or practice will result in disciplinary action as prescribed by the CUSD Disciplinary Action Guide.
- ◆ I am financially responsible for any items issued to me and that items not returned or paid for will prevent me from participating in subsequent activities and could jeopardize my graduation.
- ◆ Serious or catastrophic injury can result from participation in rehearsals, practices and performances even under optimum conditions (equipment, teaching techniques, performance areas and surfaces, etc.)
- ◆ I am obligated to follow all rules established by my teacher, school, and the Coronado Unified School District at all activities, events, performances, rehearsals and practices.

Transportation Waiver

Coronado High School will attempt to provide transportation to activities and events within San Diego County. In many cases, however, revenue limitations may not allow this to happen. Transportation for any activity outside of the county is the responsibility of the club or class. District policy does allow for the transportation of students by private vehicles driven by parents and CUSD employees. This policy requires the drivers to register with the Transportation Office at the District and written permission from each participant's parent. In the event that it becomes necessary to transport participants to activities by private vehicle:
